3. UW-250104 **East Side Improvement Co., Inc.**

General rate increase request that, as originally filed, would have generated approximately \$59,477 (131.67 percent) additional annual revenue for water services. Commission Staff and the Company have agreed to a lower additional annual revenue amount of approximately \$25,925 (54 percent) resulting in lower revised rates. The Company provides regulated domestic and irrigation water service to 44 customers in Kittitas County. This is the Company's first general rate since becoming regulated effective on July 1, 2022.
