The filing also includes proposed changes to Schedule 135 to close it to new applications and ensure an orderly transition from Net Metering to Net Billing. These changes include establishing a deadline for new Net Metering applications and introducing the Equitable Access Credit, which is designed to support continued access to distributed generation benefits for income-qualified customers.

5. UG-250830 Cascade Natural Gas Corporation

Revises Tariff WN U-3 to revise Schedule 520, Provisional Plant Rate Adjustment to refund customers for an overcollection of revenues related to forecasted provisional plant costs that Cascade did not incur in 2024. The overcollection is \$731,884 and occurred over the timeframe of March 5, 2025, to May 31, 2025. This filing seeks to apply a temporary credit to customers' bills that will reduce revenues by \$731,884 beginning on December 1, 2025, and ending November 30, 2026. A typical residential customer using 53 therms per month would see an additional decrease in their bill by \$0.13 per month over the 12-month period. Likewise, the bill of an average commercial customer using 277 therms would decrease by \$0.52 per month over the same period.
